NATIONAL NIGHT OUT AT MARRIOTT PARK, 6 PM, TUESDAY, AUGUST 1ST

We will have Sacramento Police Department Officers from our South Area Command there to meet and discuss public safety with you. We have requested a Sac PD K-9 unit visit so keep your fingers crossed that one will be available. Our Sacramento Fire Department is also scheduled to attend represented by our local Station 11 Fire Officers. Their engine will be parked on Grand River Drive at the park and they will show their equipment and discuss fire safety with you.

Our Neighborhood Watch will be on hand too with good information and hand-outs for you to take home. Supporting your Neighborhood Watch is an important way to help our families enjoy a low crime environment.

CITY NEWS UPDATE

Councilmember Rick Jennings' Office tells us that the work to replace the "Welcome to the Neighborhood" sign in the Pocket Road median just east of Greenhaven Drive has started. Many of you will remember that the old sign, which was destroyed in a May 2016 traffic accident, had a welcoming message on the side facing drivers entering Pocket and original artwork on the back side facing the Pocket. There is an effort to re-create the original artwork that was on the back of the sign, but we are unsure whether that component will be successful. As a reminder, the intent of the sign is to remind drivers that they are entering a neighborhood and to drive carefully. Thank you to Councilmember Jennings for replacing this important traffic safety sign.

City Planning has no further update on the Digital Billboard sign that is proposed to be placed at the bottom of the Freeport Water Tower behind homes on El Morro Court. This proposal is for a 70' tall one-sided digital billboard that would aim advertising at northbound drivers on I-5. The proposal includes rezoning the 9.2 acre parcel from the existing Agricultural (A) zone to the General Commercial (C-2) zone.

The billboard is part of the city's negotiated agreement over the Sacramento Kings arena, as explained in the planning notice. "The City of Sacramento and Sacramento Downtown Arena, LLC entered into a Master Lease for Digital Billboards on May 20, 2014. The Master Lease granted the right to develop and operate six digital billboards on City owned property. One of the alternative locations is the Water Tank on Freeport Blvd."

The notice from the Planning Department requested comment from our neighborhood association and SPHA submitted a comment letter on February 12 opposed to the project and outlining a number of reasons for our position. Before writing the SPHA letter, the board circulated the city notice amongst our membership via the website and email distribution list. We received several comments from neighbors, all vigorously opposed to the proposal. We did not receive a single comment in support.

Both Planning Commission and City Council approval will be required for this proposal. At this time, the proposal is not scheduled for a Planning Commission hearing or a community meeting.

VICE MAYOR JENNINGS & CALTRANS AT AUGUST 23 GENERAL MEMBERSHIP MEETING



Speakers at the August 23 General Membership meeting at Marriott Park are City of Sacramento Vice Mayor Rick Jennings and Caltrans. Vice Mayor Jennings will give a short update on city matters and then answer your questions. This is a wonderful opportunity to express your concerns with your city representative so don't miss it. The meeting is 7 pm on Wednesday, August 23 at Marriott Park.



The second speaker is Mr. Wayne Lewis, Caltrans Project Manager, who will provide an update on the upcoming I-5 rehabilitation project and the proposed sound wall next to our neighborhood. The last time Mr. Lewis provided an update was May 2016 and a lot has happened in those interim months. For example, in April of this year, Governor Brown signed SB1, also known as the Road Repair and Accountability Act of 2017, SB 1 (Beall), which may provide an additional funding source.

The \$130 million Caltrans project is primarily planned to add 13 miles of bus and carpool lanes on I-5 from Elk Grove Boulevard to Highway 50 to reduce traffic congestion. The current schedule has construction on the freeway project beginning in the spring of 2018. According to the Final Envi-


ronmental Impact Report (FEIR), the proposed sound wall would be 14 feet high and run the stretch from just north of River Ranch/Roman Oak to El Morro Court and the Freeport Water Tower.

Certainly it has been a long wait for our neighborhood and many neighbors have done their part by participating in meetings, noise studies, and contacting their elected representatives. Improvements to I-5, a primary north-south transportation route in California, should bring benefits to adjacent communities.

We will also get a chance to recognize Eagle Scout Garrett Suggs for his exemplary project in creating a new sign for Marriott Park!

MAIL THEFT PREVENTION

With break-ins of mailboxes a continuing problem within the city here are some important reminders to protect yourself and your identity.

-Do *not* use your own mailbox to send letters or bills out. Thieves are looking

for any form of drugs, medicine, money (cash, checks, money orders, etc.) and anything with your sensitive personal information including names, addresses, birth dates and social security numbers. They turn around and sell what they get to someone else.

-Do mail your letters and bills in the postal drops inside the post office. Do **not** use the big blue USPS mailboxes on the street or even outside the Post Office as even they have been stolen in the past.

-Check and collect your mail every day and do not let it pile up.

-Use the USPS vacation hold if you are going to be gone or have a friend or relative pick up your mail.

-If you are a victim of a postal theft or fraud please report the incident to the USPS at 1-877-USMAIL5 (**1-800-275-8777**) or via their website. Please provide as much detail as you can when you make your report.

-There is no standard profile for how these crimes occur. Perpetrators can be any age or physical type. They attack both the large group mailboxes and the single ones like we have here. They may be on foot or using a vehicle and it can happen anytime, day or night.

-If you see something that looks suspicious at a mailbox, yours or a neighbor, do not approach them but do call the Sacramento Police Department emergency number (<u>911</u>

from your home phone / 732-0100 from your cell phone) as it would be considered a *crime in progress*. The best thing you can do is be a good witness and write down everything you observe especially a vehicle license plate number.

As an added prevention tool the Sacramento PD recommends that if you have the means to install a security camera that can observe and record any actions by people or vehicles at your mailbox. Those types of cameras have been very effective in helping solve personal mail theft crimes.



15 Home Modification To Making A Home Safer To Age In Place

Many of us have parents or other loved one who wish to stay in their homes but find safety obstacles in the way of reaching that objective. Without some alterations, everyday items and run-of-the mill tasks become hazards. **Here are 15 changes to consider:**

- 1. Open up the space in rooms. Make sure there is a clear path. Think purging.
- 2. Remove anything that's a trip hazard. Area rugs can be particularly hazardous.
- 3. Move items used often within easy reach.
- **4.** Lower the temp on the water heater. Consider 120 degrees.
- 5. Add extra lighting.
- 6. Add traction slips to the bathroom floor and floor of bath/shower.
- 7. Install an elevated toilet seat.
- 8. Add levered handles to doors and faucets vs. round knobs.
- 9. Install a doorbell and smoke detector with lights.
- 10. Get a Clapper or make your house smart. The Echo is one such product available on Amazon. There are others.
- 11. Install grab bars. Think bathrooms, hallways, next to bed, etc.
- 12. Widen doorways, especially if a wheelchair, walker or even crutches are used.
- 13. Add a stair lift.
- 14. Install a walk-in tub.
- 15. Install wheelchair ramps, if needed.
